Eligibility of Competitor: All competitors must be 4 years and older, and all competitors must agree by the rules of the organizing committee

Mandatory Equipment:

Uniform – Open Style

Sparring Gear – All Sparring competitors must bring their own safety gear including Chest Protector, Head gear (White, Blue, or Red color), Shin/Instep guard, Forearm guard, protective cup and Mouth guard.

Optional Equipment: Sparring Gloves and Foot/Toes Protector

2. Breaking – No boards will be provided with the registration fee. All boards for the breaking competition *must be purchased at the Door for fair competition.*

0. Power Breaking (Hand) Division – No Bricks, ONLY Pine Boards (Age 7 & under: 3/8 inch, Age 8 to 11: 1/2 inch, Age 12 & older: 1 inch – 1 point each broken board)

0. Free Style – Presentation Time (1 minute 30 seconds includes set-up time) – Min. 3, Max. 5 Skills, up to 7 boards. ****You have to have your own board holders if you need more than 3 holders.**

Scoring Criteria (Free Style) - 3 Judges: Competitors can try only ONE time to accomplish breaking

Accuracy	Skill	Accomplishment
0.5 point each broken board	Add 0.5 for each turning and jump kicks	1 point deduction each missed board

Black Belt Skills - 360 Degree (1 +), 540 Degree (2+), 720 Degree (3+) extra points

Ex) Try 5 boards, and broken 4 boards with one 540 degree turn kick (4 X 0.5) - (1 missed X 1) + (1 X 0.5 Turn kick) + 2 extra point = 3.5points

Weigh Category – Form and Breaking

All ages and All ranks (Male and Female) – Light and Heavy weight division

3. Sparring Division - Single Elimination System for All Ranks

3-1. World Class Sparring (Black Belt ONLY) for Cadet (Age 12 – 14) and Junior (Age 15 -17) Division – Double Elimination System (E-Gear Electronic Scoring System)

The competition rules regulate and govern all matters pertaining to Taekwondo competition at all levels sanctioned or promoted by USAT. However the following special section of the Junior Competition (Safety) Rules shall further apply to junior sparring divisions as stated below

1. Junior Competition (Safety) Rules

1) No Head Contact – Age 11 & under (Color Belt)

- Any Techniques contacted to the head area which does not cause any injury, will be given a warning by the referee (“Kyung Go”)
- Any technique, which **causes injury to the head area will result in a one-point deduction by the referee**
- If the competitor cannot continue because of the injury to the head area, the attacker will be disqualified.

Note: Inability to continue because of fright, crying or loss of will following a kick to the head which did not cause injury does not constitute grounds for disqualification of the attacker.

2) Junior Safety Rules – Ages 11 and under Black Belt and Age 12 and up (Color Belt)

- The competitor is allowed to kick to the facial area: however **the kick MUST be light contact with absolute control without causing any injury** or excessive contact, or the appropriate penalty shall be invoked.
- The competitor who **executes a successful technique (Light contact ONLY) will be awarded.**
- The competitor who executes a kick to the face which results in a minor injury shall receive a one-point deduction. A minor injury is defined as abrasion or bleeding caused by non-excessive contact. The referee, with or without consultation with the tournament physician, shall determine if the abrasion or bleeding is a minor injury, and if the attacker is a non-excessive one.
- The competitor who executes a kick to the face which results in the inability of the opponent to continue sparring because of injury shall be disqualified. The referee shall determine if the attack is an excessive contact, and if the injury is major one.

3) Age 12-17 (Black Belt) and Senior Division (All Belts)

- In competition, **the senior black belt adult rules (Light Contact ONLY) shall apply for these divisions.**

Scoring Criteria:

1. One (1) point for Punch on trunk protector,
2. Three (2) points for a valid kick to the trunk protector,
3. Three (3) points for a valid Turing kick to the trunk Protector
4. Three (3) points for a successful kick to the head
5. Four (4) points for a valid turning kick to the head
